- Vendors selling prepared foods must comply with the State of Nevada health regulations or have a Cottage Food License.
- Attach a copy of your State of Nevada Health Department Permit or Cottage Food license.
- Provide proof of liability insurance naming Great Basin Lavender Association as an additional insured.
- Vendors must provide their own power.

#### Additional Requirements:

- Vendors must supply their own tables, chairs and tents.
- Setup begins at 8:00 am. Vendors must be ready by 9:45 am
- Cleanup and removal must be completed by 5:00 pm.

#### Payment Details:

- **Payments must be made no later than June 25, 2026, or your spot will be forfeited.**
- Payment methods: Check, cash or electronic payment (details will be provided upon approval).

#### Cancellation Policy:

- Refunds will not be issued for cancellation of this event after June 25, 2026. No exceptions.
